A. Reinke noted the County assigned a value for the sick leave liability of zero. Gerry Gemmill motioned to authorize Steve Reinke to sign the ILA. Cody Rohrbach seconded. All were in favor. Motion carried.

## 5. 2020 Operations Budget and Capital Planning

Steve Reinke explained because the City of Spokane opted out of the Regional partnership the current Finance Committee is Gerry Gemmill, Bryan Collins, Tonya Wallace and Steve Reinke. For the initial budget cycle, the Board decided that the full Board will act as the Finance Committee and finance related items will be part of the regularly scheduled meetings. The proposed budget will need to be ready by early October. Steve Reinke added that interviews for the position of Finance Manger would be held that afternoon.

Lori Markham said on August 1, 2019, two fire dispatch trainees will have completed training and will be assigned to a power shift. Legal counsel for SREC and City of Spokane are working on an agreement for fire dispatch services.

Bob Schwent advised battery testing procedures have begun and many radio site batteries need to be replaced. An RFP from the County has been initiated to begin battery replacements with an estimated cost of \$150,000.
